Need final figures from Mike Cohen for what money was received at the gate. That will wrap up this year's rally.

Kathy Waters has the *Antique Motorcycle Club of America (AMCA)* with an article on the *Chix at the Crossroads* ride that she participated in this summer with her 1987 K75T.

MOA now has joined forces with the *AMA*. Two separate dues, but the MOA can be represented by the *AMA* in government negotiations.

OLD BUSINESS

Tim Koester has accepted the nomination for webmaster.

Mike Cohen awards Eddy Boskamp for 25-year membership.

NEW BUSINESS

Heidi Goehring said she is starting a collection in Shad's memory for a brick at the WI Motorcycle Memorial. She will collect money for the brick and any additional monies will be donated to his mother. This collection was started by a nonmember. Mike Lambert made the motion to pay half the cost of \$130. Dewayne seconded. A collection was taken up at the meeting tonight and monies were given to Heidi. It was agreed that the motion be tabled for a short term. We passed the hat and collected a total of \$571 + \$60 previously collected for Shad. After the memorial brick is

purchased, the balance of cash will be given to his mother, Donna. Motion is rescinded.

We have a person who is qualified for membership tonight. The club will take a vote for Greg Stoller from Pewaukee. The vote to accept Greg was unanimous. Kathy made the motion to destroy the ballets, Ross Bennett seconded, all in favor.

Shad was on the Constitution Committee and had one more year to serve. Bob Lannin made a motion to use the existing list of nominees for the Constitution Committee to fill Shad's remaining 1 year term. The two highest votes will fill the two-year terms, the third highest number of votes will fill in the one-year term for Shad, which will effective immediately. You will only vote for two people, but we will use the top three number of votes. Dave Kurth seconded the motion. All in favor.

Mike Lambert said we have a simple popular vote this year. That should avoid confusion on the ballots.

Ross Bennett asked if anyone is interested in the chili cookoff against the Ducati Club. It will be held at Moto Union, on Saturday, December 14th. Five people from each club would make a batch of chili and will be judged by attendees. Approximate time is 11 am -1 pm with voting tallied at 1:15. Make the chili ahead of time and put it in a crock. Vinny Tomasello, Christine Ledezma, Dave Kurth, Mike Lambert, and Jeff Johnson are the five representatives from the WI BMW Club.

Mike Lambert stated over the last couple of years the club does not match its constitution. Over 80% of the club time and energy is directed towards the rally. We do not really have a social or riding club. If we are still looking at so much focus on is the rally, we should look at 501(c)3 status as a fully functional Non-Profit. Mona said there are times we are being charged tax because we are a 501(c)7 instead.

Ross Bennett has a couple mileage forms printed out if you need them.

There was a question during the October meeting as to whether or not the current meeting location, day and time, is what club members want? It was originally brought up about weekend meetings during the day. To add to this discussion, there was previous talk about the fact Fridays in the summer pose a

problem for anyone that wants to attend rallies or other 3 day trips somewhere.

I took it upon myself to build a chart with all possible options, including the option of having different summer and winter days and times. The form is pretty self-explanatory. 
